#### **BACKGROUND**

Ngarrindjeri are the traditional owners of the Lower Murray, Lower Lakes, Coorong and Murray Mouth region and adjacent areas. The Ngarrindjeri Nation consisting of wetlands Coorong, Lower Lakes and Murray Mouth have been internationally recognised for their diverse ecosystems.

Ngarrindjeri through our regional governance body, the Ngarrindjeri Regional Authority Inc. (NRA), are focussed on progressing the interests of the Ngarrindjeri Nation. The NRA Board membership includes the chairpersons of key Ngarrindjeri organisations, elected community representatives and the chairs of key representative committees such as the Ngarrindjeri Heritage Committee and the Ngarrindjeri Native Title Management. The NRA has also established two commercial operation arms: Ngarrindjeri Ruwe Contracting Pty Ltd (NRC) and Ngarrindjeri Enterprises Pty Ltd (NEPL) that are responsible for contracting and delivering employment for Ngarrindjeri people and economic development projects, respectively.

Established in 2009 NRC is a wholly owned subsidiary of the NRA. NRC operates on the foundation of Ngarrindjeri cultural values. At our heart is a deep knowledge and commitment to the land and sea, drawing on the wisdom and lore of the Ngarrindjeri, the traditional owners and custodians, within a contemporary setting.



NRC is a holistic provider of environmental management services, across four key divisions

- Conservation and land management
- Native nursery operations
- Technical consulting, and
- Trade and labour hire.

NRC continues to explore new and exciting market opportunities, including: native plant products; wildflower industry opportunities; growing and supplying wholesale native food; and supporting the Ngarrindjeri catering and native food business, Little Local Co.

# Kungun Ngarrindjeri Yunnan Agreement (KNYA)

NRA Inc. and NRC Pty Ltd (as trustee for NRC Charitable Trust and NRA Inc.) have entered into a Kungun Ngarrindjeri Yunnan Agreement (KNYA) (Funded Deed Agreement) with the South Australian Government, Minister Regional Development, that seeks to support Ngarrindjeri caring for country programs.

The Funding Deed known as the "South Australian River Murray Sustainability Program, Regional Development and Innovation Fund (Sustainability Program)" enables Ngarrindjeri participation in the Sustainability Program. It is also primarily designed to build Ngarrindjeri capacity to better engage in natural and cultural resource management in the long-term.

### **Business Development Manager**

The Business Development Manager, by reporting to the NRC COO, is instrumental in contributing to the specific project under the Sustainability Program known as "Increasing Aboriginal participation in Natural Resource Management (NRM), primary production and associated industries in the SA River Murray Region".

#### **KEY DELIVERABLES**

Contribute to the ongoing commitment of NRC Pty Ltd to transitioning to an organisation that secures more contracts from sectors outside of government. The occupant of the position will play a key role in managing the ongoing work of the NRC through: supervision of projects secured by NRC, staff management, compliance with government reporting requirements, and acting as a key point of contact for enquires relating to the work of NRC.
